
Amherst Township Lot 14

Summary:

The 100-acre lots were a block of extremely valuable lots that lay south of the 1000-acre Denson Grant in Upper Nappan. Deed research shows that only 5 lots with a north/south orientation occupied the land between the Ox Bend of the Nappan River on the west and a block lots adjoining Cobequid Road on the east: lots 17, 16, 15, 14, and 25. The Michael Keiver homestead occupied lots 15 16, and 17. The Noiles family occupied Lot 14, and the Casey family occupied Lot 25. These lots were bordered on the north by the 1000-acre Denson Grant later purchased by Thomas Cochran. Amherst Township Lot 1 east of the extreme gore of the 1816 Samuel McCully Grant formed the southern boundary.

In 1779 John Stuart purchased Amherst Township Lot 14 from Patrick Porter. Following John's death, his son Charles Stuart sold at least part of the property to Edward Noiles Senior. Edward Noiles Senior passed 25 acres of the property north of Nappan Road to his son Josiah Noiles in 1863. Unmarried Josiah Niles left the property to his nephew James Wilson.

Edward Noiles Senior also deeded long narrow portions of the property south of Nappan Road on Lot 14 to his sons Albert and George. The brothers later deeded portions of their land to their brother Robert. The original boundary between Lots 14 and 25 was obscured when Robert C. Noiles acquired portions of the Casey properties to the east. Robert's estranged wife Jane Gould later acquired the westernmost portion of Lot 14 and the Bacon family acquired the central and eastern portions of the lot.

Note:

Nathaniel died in 1857 in Sackville so this sale may not have been completed and/or the property reverted to Edward Noiles.

In 1862, Edward Noiles Senior began to dispose of his properties to his remaining sons. Edward Noiles Senior probably died in late 1862 or early 1863 as his probate documents are dated January 1863. The deed sequence is confusing as the deeds are also registered 1863. Edward Noiles Senior deeds the property north of Nappan Road to his son Josiah. Edward Noiles Senior conveyed the 75 acres of Lot 14 south of Nappan Road to his sons Albert, George, who subsequently conveyed property to their brother Robert. Edward Noiles Senior also conveyed 1/4 shares in a one-acre lot adjacent to the Nappan River, bordered on the north by the Denson Line and on the east by a road, probably today's NS-2.

1863 Edward Noiles to Josiah Noiles (Deed Book HH, p. 48, registered 1863)

Note:

Property 1 sounds exactly like the property described in the 1848 deed to Rufus and Albert Noiles. However, deed descriptions from the neighbouring Cochran property indicate that Josiah Niles lived on the property. After his death, the unmarried Josiah willed the property to his nephew James Wilson.

Notes for further study:

A map of the William Keiver estate shows the location of the Keiver and Pugsley properties. Several properties referenced in the Noiles deeds can be seen on this estate map. (Nova Scotia Probate Records, Estate Files 1764-1938, Nos. 1065-1113 (J-K) viewable on Family Search. The estate map is on image 721.

Robert Coates had purchased the George Moore Lot in 1881 (Deed Book 4, p. 29). The Moore Lot north of Nappan Road adjoined on the west.

Ed Noiles is shown on an 1860 map of Cumberland County on the north side of Nappan road just west of Wm. Casey. To view this map online, go to the Nova Scotia Provincial Archives Historical Maps section at https://archives.novascotia.ca/maps/ and search for "Cumberland County". The map is titled "Cumberland County Grants" and dated 1860. Controls at the bottom of the page will allow you to enlarge and rotate the map. You can also download the map and then use the controls on your computer to enlarge and rotate the map.

It was likely Edward Noiles Senior who purchased a lot on the east side of NS-2 south of Nappan Road from Mary Gould, widow of Joseph Gould 2nd in 1847. A document in the probate papers mentions a charge against the estate for services provided in a court action between Edward Noiles and Mary Gould.

When Cochran's Lot S to the north was sold in 1873, its southern boundary was (from east to west) "lands of Mrs. Daniel Casey, George Gould, Josiah Niles, George Moore, and Mrs. William Keiver." (Deed Book RR, p. 208). George Moore's property on lot 15 was part of the original Keiver estate. Josiah Niles was on Lot 14. George Gould and Mrs. Daniel Casey were on Lot 25.

When Cochran's Lot S to the north was sold in 1891, its southern boundary was (from east to west) "lands of the widow of Daniel Casey, Peter Gould, James Wilson, Robert Coates, and lands purchased by Lowe from George W. Pugsley." (Deed Book 29, p. 423).

In his will of 1881, unmarried Josiah Noiles left both of the properties deeded to him by his father in 1863 to his nephew James Edward Wilson, son of his sister Sarah.

The purpose of this document was to establish the location of Lot 14 between the Keiver properties and Jeremiah Casey on Lot 25. Noiles and Bacon family descendants may be interested in tracing the properties further. The following list provides a partial deed trail:

1873. Robert bought 73 acres from Nathaniel Casey and immediately mortgaged to Bent (Deed Book RR, p. 308.)

1873 Bent mortgage. (Deed Book RR, p. 309)

1897 Robert B. Dickey to James A. Dickey (Deed Book 47, p. 174)

1899 James A. Dickey to R. Thompson Coates (Deed Book 54, 434). Robert Noiles Lot

1902 R. Thompson Coates to Frederick Noiles Deed Book 62, p. 409) Robert Noiles Lot

1902 Frederick Noiles to Jane Gould (Deed Book 63, p. 162) Robert Noiles Lot

1903 Sherriff Logan Albert Noiles to CWHolmes

1903 CWHolmes to Howard F Noiles. (the lots above)

1907 Jane Gould to Cassie McDonald (Deed Book 86, p.162). Cassie McDonald. 30 acres of Noiles Lot

1916 Jane Gould to S. A. Logan (Lime Kiln right of way). She must have also sold him the 5-acre lot because he later sold a 1/2 interest in it to Fillmore and then the whole property. They

also obtained a right-of-way from Styles. Frank Smith, who owned a part of Lot 1 to the south sold a lot of unknown size next to the lime quarry to Fillmore. This deed includes a survey of the lot.

1922 Jane Gould to Laura Secord (Deed Book 150, p. 190) 1939 Jane Gould to Aubrey Noiles (Deed Book? P. 493).

1892 Albert E. Lawrence to Thomas Read. Bounded by Porter Road

1910 Joshua, George, Fred Gould to Robert Bacon (Deed Book 99, p. 292). Bounded on west by Porter Road

1913 Robert Bacon to W S Bacon (Deed Book 114, p. 268) Gould Lot adjacent to Albert Lawrence

1949 L. Bacon to G. Bacon (Deed Book 200, p. 538) Dower Lots

Eventually the property went to James R. Ramy (Lot 25 portion), Robert Bacon, Laurie Bacon, Clinton Bacon
