

Summary:

The Samuel Holt homestead was located on the original 20,000-acre grant made in 1764 to Captain Adam Gmelin. In 1771, Col. J. F. W. DesBarres acquired the northernmost 8,000 acres of the Gmelin Grant in a court-ordered sale to cover a debt owed by Gmelin to DesBarres. At first, DesBarres leased his properties, but in 1817 he began to sell them to former tenants. After his death in 1824, his son Augustus continued selling the properties. The DesBarres estate eventually became the communities of Maccan, Nappan, and Fenwick.

Samuel Holt's lot in Fenwick was bounded on the north by the Thomas Holt homestead and on the east by the Gmelin Line, the lot's shared boundary with the adjacent 1816 Samuel McCully Grant. The lot was bounded on the west by Lot 17 in the bank of lots west of today's NS-2 and south of Fenwick Road. Its southern boundary was the rear line of DesBarres' 8,000-acre tract. Ripley Branch Road off NS-2 runs through this lot.

Samuel Holt purchased the property from Augustus DesBarres in 1865 and the lot was almost immediately divided into an eastern and western westion. Subsequent owners of the property included Alexander Lewis, James McLaurin, Osborne Ripley, Rufus Smith, Oman Lewis, William H. Ripley, Joseph E. Ripley, William T. Pipes, J. Clarence Purdy, A. C. Higgs, and John Dale.

1875 Alexander Lewis to Robert B. Dickey Mortgage (Deed Book UU, p. 198)

Grantor: Alexander Lewis of Nappan, husbandman and Mary (Ripley) his wife

Grantee: Hon. Robert B. Dickey of Amherst, Senator

Price: two hundred and fifty dollars

Property: "the Eastern part of lot purchased by Samuel Holt from Augustus Wallet DesBarres

Price: 150 dollars

Property: 2 properties, the second of which was the eastern half of Samuel Holt's lot Property 2: "the Eastern part of a lot purchased by Samuel Holt from Augustus Wallet

DesBarres containing Fifty Acres more or less"

Boundaries:

"bounded Westerly by the Western half of the lot Owned by Oman Lewis dated thirty December A.D. 1865"

1906 Charles R. Smith to James F. McLaurin Release of Securities (Deed Book 80, p. 289)

According to this document, McLaurin's mortgage with Arthur Dickey had been transferred through a circuitous route to Smith who had collected \$690 from McLaurin and declared the mortgage fully paid. However it appears the mortgage had not been paid, or a new mortgage had been taken as Smith later obtained ownership of the property.

1912 Richard B. H. Davison Sheriff to Charles R. Smith (Deed Book 108, p. 564)

Charles R. Smith was charged with selling the property. James McLaurin's wife Elizabeth then owned an "equity of redemption" in the mortgage. So perhaps she did receive a share of the sale price after Smith had taken his foreclosure settlement.

1926 Charles R. Smith to Osborne Ripley (Deed Book 163, p. 426)

Grantor: Charles R. Smith of Amherst, Barrister and Mary G. Smith his wife

Grantee: Osborne E. Ripley of Fenwick, Farmer

Price: one dollar

Property: "the eastern part of lot purchased by the late Samuel Holt from the Late Walter

Augustus DesBarres containing fifty acres more or less"

Boundaries:

"bounded westerly by the western half of the lot owned by Oman Lewis, eastwardly by the old McCully line (so called) and more fully mentioned and described by the said Samuel Holt's deed to one Alexander Lewis and which said deed is dated the third day of December A. D. 1865, the said lands and premises hereby sold and conveyed being the same mentioned and contained in a deed of conveyance made by R. B. H. Davison Esquire High Sheriff of said

County of Cumber dated the seventeenth day of August A.D. 1912 and recorded in Book No. 108, page 564 as No. 1194 - 1912 in the Registry of Deeds at Amherst."

Note:

Osborne Ripley subsequently sold smaller lots to Ira Ripley, Arthur Phillips, Alfreda Jones, Joseph A. Lawless, Conan O. Ripley, Sheila Elizabeth Ripley and Glendon McGillivary, Clyde Elliot, and Gerald O'Brien. This list of names corresponds with the list of people with properties on Hwy NS-2 given by Myrtle Chappell in Fenwick 1798-1978 pages 74-75.

Notes for further study:

T. Holt and A. Lewes are shown in this location near the end of a road that became today's NS-2.
