William Keiver/Robert Puglsey Homestead to 1860

Summary:

In 1805, Michael Keiver purchased 100-acre lots 15, 16, and 17, located in Amherst Township. The western border of the homestead was formed by Lime Kiln Brook and the neighbouring property of J. F. W. DesBarres, originally the Gmelin Grant. The northern border was the Ox Bow bend of the Nappan River and a portion of the original 1000-acre grant to Henry Denny Denson later acquired by Thomas Cochran.

In his will, Michael Keiver left the 350-acre homestead farm to his wife Margaret (Hunter) and to his three youngest sons. However, by 1842, Michael's son William Keiver (1800-1860) and Michael's son-in-law Robert Pugsley (1791-1864) owned the entire homestead jointly.

William Keiver acquired neighbouring properties of Francis Gould and Joseph Gould 2nd and sold a small parcel to William Bird. After William Keiver's death in 1860, his property was devised to his widow Nancy (Jenks) and four daughters Francis, Mary Abba, Ida, and Alice. Robert Puglsey conveyed his lots to schoolmaster George Cruickshank and his son David, who subsequently conveyed to Leonard D. and George W. Puglsey.

The original Michael Keiver homestead eventually became the homesteads of Charles T. Read, Price Read, Gordon Bacon, Robert Coates, Walton Bacon, George Allan Stiles, Henry J. Cousins, Jacob Porter, and others.

It's unclear whether the land of Thos. B. Gould mentioned in this deed is the entire 50-acre piece William Keiver purchased or just the 11-acre piece laid off for Thomas as part of the sale.

1856 Alfred Atkinson and Mary Gould to William Keiver (Deed Book AA, p. 45)

Note:

Joseph Gould 2nd purchased this property in 1844 (Deed Book V, p. 218). It was bounded on the west by the Roach Line, east by today's Lime Kiln Brook, and north by the Nappan River, straddling Nappan Road. The property William Keiver purchased from Joseph's widow was the portion of the 23-acre lot that lay south of Nappan road. This was a court-ordered sale of 4 properties belonging to the late Joseph Gould 2nd to cover debts and expenses. The properties had been advertised in the Halifax Royal Gazette for 30 days sometime after the August 18, 1856 court order.

Notes for further research:

A map of the estate of William Keiver shows the location of the Keiver and Pugsley properties. (Nova Scotia Probate Records, Estate Files 1764-1938, Nos. 1065-1113 (J-K) viewable on Family Search. The estate map is on image 721. A written description of the allocation of the properties beginning on image 745 is very useful as it mentions neighbouring properties not shown on the maps.

An 1860 map shows a Mrs. Keiver, a D. Pugsley and Nathaniel Casey located east of today's Lime Kiln Brook and a road called Baker's or possibly Baken's Rd., probably today's Lower Porter Road.

To view this map online, go to the Nova Scotia Provincial Archives Historical Maps section at https://archives.novascotia.ca/maps/ and search for "Cumberland County". The map is titled "Cumberland County Grants" and dated 1860. Controls at the bottom of the page will allow you to enlarge and rotate the map. You can also download the map and then use the controls on your computer to enlarge and rotate the map.

The 1873 A. F. Church map shows Mrs. Keiver, D. Pugsley, G.B. Moore and A. Stiles east of Beaver Lake Creek, today's Lime Kiln Brook.

Myrtle Chappell discusses the Keiver homestead in Fenwick 1778-1978, pages 80-82. She mentions several homesteads once located on the original homestead of Michael Keiver including Price Read, Charles Read, the Stiles homestead later owned by Kenneth Smith, Walton Bacon, Gordon Bacon, Jacob Porter, David Pugsley, and G.B. Moore.

The Ernest Coates hand-drawn map shows the following homesteads located on the original Michael Keiver homestead:

#29 Farm of Alan, Allison Stiles, Kenneth Smith, grandson of Alan.

#30 Farm of Roderick Read, son of Charles Read & gson of Burton Read

#31 Farm of Gordon Bacon & Helen (Ripley) Bacon

#32 Farm of Jacob, Sylvester, Russell Porter (Jacob M Ida Read)
